# Inter Canyon League Minutes of the General Meeting Tuesday, April 6, 2021 at 7:00 PM Live Streaming

#### I. Call to Order

The meeting was called to order at 7:07pm by President Sarkissian.

#### II. General Announcements & Discussion

a. General Community Announcements

Mary Schreiber noted that weed abatement notices are being sent out. Phil McWilliams added that people can call the agency to request that their deadline be extended.

Phil also said that the History Committee plans on meeting again on the first Saturday of May, for everyone who is fully vaccinated against COVID-19.

**b.** Cougar Conservancy—Korinna Domingo

Korinna, founder of the non-profit Cougar Conservancy, described resources available to local residents for living with mountain lions (cougars). For example, after Modjeska resident Vallary Townsell lost one of her goats to a mountain lion in March, the Conservancy built her a cougar-proof animal enclosure.

Upon request, the Cougar Conservancy can visit a site and make recommendations for making it cougar-proof, such as by ensuring that animal enclosures have roofs that can support 200 pounds, and that they have no gaps over four inches wide.

To report mountain lion sightings or conflicts, or to request more information, people can call the Cougar Conservancy at (800) 930-1087, or visit cougarconservancy.org. Conservancy videos are also available on Youtube. In addition, Korinna is interested in having a venue available for demonstrating cougar-proof pen-building.

In answering one of the questions from the audience, Korinna stated that automobile accidents are not the main cause of mountain lion fatalities, but they do get the most publicity. It was reported that OC Public Works could install more or better signs on Santiago Canyon Road to try to avoid cougar collisions: the best of these, but the most expensive, were said to be able to flash warning lights upon detecting the presence of a mountain lion.

c. Canyon Watch Update—Bic & Keith Edwards

Cle Robinson reported that Keith and Joe did an excellent job in getting the new Silverado (Franklin) radio repeater up, now moved slightly to a spot on Fred Dohrman's property. They would like to get everyone's radios reprogrammed for the new frequency by April 17—this should include Modjeska residents, so that their equipment will also work in Silverado. Francesca Duff added that an additional benefit from the reprogramming is that more direct channels (not handled by the repeaters) are supported.

d. Emergency Preparedness---Joanne Hubble

Wireless service from AT&T is still being investigated. The Fire Station 14 and Fire Station 16 sites look "promising."

Maps are being updated to show addresses of horses (in case needed for evacuations).

**e.** Friends of the Library—Fran Williams

Fran said that a swap meet is planned for the second weekend in June. Volunteers would be especially appreciated on Friday to help with setup.

Fran will also be meeting with the new librarian, Jessi Ruge. Library stacks might re-open by the end of April, and the children's department will be worked on next.

**f.** Country Fair—Jane Bove

Geoff described this year's fair as "in limbo."

g. CAN Committee—Dion Sorrell

Dion is working with Danny Graham to start a canyon scouting program focused on emergency preparedness, partly to make up for the loss of the Modjeska Fire Explorer post. To "grow a culture of preparedness" and lessen fear and anxiety, children could learn walkie-talkie use and how to help their parents.

There are some limitations, such as privacy considerations, on what civilians (not emergency workers) can do to help others.

a. President—Geoffrey Sarkissian

Geoff is hoping to resolve any Bond Fire grant application problems in a few days.

**b.** Vice President—Dion Sorrell

No report.

c. Secretary—Scott Breeden

The minutes of the March meeting were approved 4-0.

d. Treasurer—Francesca Duff

ICL renewed the Constant Contact service that Joanne uses for email notices. ICL also expects that about \$4,000 will be needed at some point to pay for radio licenses; Francesca has applied for a grant for that. ICL's fire grant funds are ready.

The April financial report was approved 4-0.

#### **IV. New Business**

Cle thanked everyone who donated money for the new Canyon Watch equipment. He also volunteered to give classes on radio usage to the current block captains.
